The **Provisional Merit List** of candidates for admission to 4 Years B.Tech in Agricultural Engineering course under Faculty of Technology through Decentralized Counseling for the session 2019-20 is hereby notified for information to all concerned. Candidates are requested to report **personally** for counselling and admission, to be held at **Swami Vivekananda Auditorium** of the University at **Pundibari, Cooch Behar** on **26th August 2019 (Monday)** **by 1.30 p.m. strictly and positively**, with original and attested copies of all the following documents, failing which the candidature of the candidate will be cancelled.

The remaining or resulting vacant seats, if arises, will be filled up through spot Admission (Date will be notified in the University website). The candidates who will report during 1st counseling will only be called for Spot Admission along with the wait listed candidates, if required. A candidate who was called in previous counseling but failed to appear in the counseling will not be entitled to appear in successive counseling.

After commencement of classes of 1st Semester within one month if any vacancy arises due to discontinuation of any student, the University will fill up that seat from the existing merit panel of Decentralized Counseling 2019 through spot admission.

Information submitted in the online Application Form will be treated as final and no change will be entertained in future. The candidates having query, if any, regarding merit score published by the authority, may send email to the id **ubkvadmission@rediffmail.com** within **22.08.2019 (upto 3:00 pm)**. The email id which was registered by the applicant at the time of online submission of admission form will only be considered for any correspondence.
