The award of Degree to candidates registered for the Ph.D. programme prior to July 11,2009, shall be governed by the provisions of the then existing Ordinances/ Bye laws/ Regulations of the institutions awarding the Degree in the same or relevant subject shall be exempted from the requirement of NET/SLET/SET. a) Ph.D. degree of the candidate awarded in regular mode only;		
b) Evaluation of the Ph.D. thesis by at least two external examiners:

d) Candidate has published two research papers from his/her Ph.D. work out of which at least one must be in a refereed journal;
