2. Service to be provided by the Agency:

- 6. The application must be accompanied with rough estimates of the proposed work.

The participants will have to remain present in an interaction meeting for an online presentation of 30 minutes (20 minutes presentation and 10 minutes for discussion) about the credentials of the vendor(s) with their creative ideas on the said work in any pre-fixed date with the University authority on the scheduled date and time of opening of EOI.
- 8. **Award of contract:** After the Process of EOI, the UBKV authority will invite limited NIT for the said job and UBKV will award the contract of service to the Agency whose bid would be lowest, responsive, complete and in accordance with the requirement.
- **9. Signing of Agreement:** UBKV shall prepare the Agreement duly incorporating all the terms and conditions of Agreement between UBKV and Successful Bidder. The successful bidder will be required to execute the Agreement on a Non-Judicial Stamp paper within 15 days from the date of issue of the Letter of Award.
