#### **EXPRESSION OF INTEREST FOR EXCAVATION OF POND AND FISH FARMING AT REGIONAL RESEARCH STATION (OLD ALLUVIAL ZONE), UTTAR BANGA KRISHI VISWAVIDYALAYA, MAJHIAN, DAKSHIN DINAJPUR**

Expression of Interest (EOI) in a sealed cover is hereby invited from interested and experienced bonafide parties/agencies /organization for excavation of a pond at an area of 3.00 acre and subsequent fish farming for five (05) years at Reginal Research Station (Old Alluvial Zone), *Uttar Banga Krishi Viswavidyalaya*, Majhian, Dakshin Dinajpur, West Bengal-733133. The details of the work and other terms and conditions are specified below.

Particulars of work	:	Excavation of a pond/water body at an area of 3.00 (three) acre and carrying out fish farming for five (05) years.
Scope of work	:	<p>-Excavation depth: 5'-00"</p> <p>-Soil to be excavated: 653400.00 cft approx.</p> <p>-Carrying of soil: 13068 trolley (@50cft per trolley) to the location inside the campus as to be specified by the Reginal Research Station (Old Alluvial Zone), <i>Uttar Banga Krishi Viswavidyalaya</i>, Majhian, Dakshin Dinajpur. Carried soil shall have to be filled in low lying areas inside the campus and filled up soil shall have to be dressed and levelled in proper shape as per the direction of the In-Charge, RRS (OAZ), Majhian.</p> <p>- Civil work for making an office cum store room (20'x10') adjacent to the proposed area. Proposed office cum store room shall be made with brick wall, cemented floor and CGI sheet roofing etc.</p> <p>-Electrification at the spot which shall include internal and external electrification of store cum office, illumination surrounding the new pond, pumping arrangement for lifting underground water etc.</p> <p><b>N.B. All Civil &amp; Electrical work shall be carried out under the supervision and guideline of the University Works Department.</b></p> <p>-Recurring investment for fish farming on fingerlings, fish feed etc.</p>

**Note:** 1). In case of any unscheduled happenings like natural calamity or holiday on the aforesaid dates, the next working day will be treated as scheduled / prescribed date for the same purpose.

3). The Authority reserves the right to defer any date as scheduled, if required.

### General Terms and Conditions:

1. Submission of Expression of Interest and presence in pre-bid meeting shall be mandatory to be eligible for bidding thorough tender. After the pre-bid meeting, the tender procedure shall be started. The eligible bidders shall only be allowed to participate in the tender process.
2. The competent authority of the University reserves the right of withdrawing from the process of tender at any point of time. The University Authority is not bound to accept the highest offer or any other offer and will not be bound to provide any reason for the acceptance or rejection of any offer. However, the bid will be accepted only after the bid found to be above the **reserve rent** per year for use of the land area inside the campus.
3. A permanent citizen of India shall be allowed to participate in the process. An intending bidder must produce valid Adhaar, PAN and GST registration number (if applicable) issued by the appropriate authority during submission of expression of interest. Any association intending to participate in the tender shall have to be constituted as such under the law and registered under the relevant act applicable to it.
4. The intending bidders are requested to visit the spot at the Regional Research Station mentioned at the above site in the specified dates and time period. The intending bidders may also contact the Office of the Officer-In-Charge, Regional Research Station (Old Alluvial Zone), *Uttar Banga Krishi Viswavidyalaya*, Majhian, Dakshin Dinajpur, West Bengal, Pin: 733133, if any clarification is needed before participation in EOI/Pre-bid meeting.
5. The bidders shall submit tender along with Earnest Money as mentioned above. The Earnest money shall be treated as security deposit for the successful bidder during the entire period of operation *i.e.* five years. A money receipt will be issued only on clearance of Demand Draft from the bank.
6. The quoted rent per year against the use of the land area below the reserve rent for the first year as mentioned shall be rejected.
7. The party at his own cost shall excavate the pond and run the fish farming. The bidder shall have to contact with the Officer-In-Charge concerned to obtain valid permission from there on every occasion while he needs to execute specified job. The excavation and other scope of work shall conform the standard as specified. The carrying of excavated soil and the position of unloading the soil shall be done in consultation with the Office of the Officer-In-Charge, Regional Research Station (Old Alluvial Zone), *Uttar Banga Krishi Viswavidyalaya*, Majhian, Dakshin Dinajpur, West Bengal, Pin: 733133.
8. No liability of theft or damage of the machinery used for excavation or fish farming by miscreants shall be borne by the University during the entire period of the project after acceptance of the work order.

9. Care should be taken so that no office and farm properties like roads, godown, electric supply lines, internet lines etc. as well as other standing crops are damaged during execution of works. If there shall be any such damage, the entire liabilities shall be borne by the successful bidder.
10. The successful bidder shall only be allowed to initiate the works after acceptance of the work order and deposition of the rent in advance for the first year.
11. The successful bidder shall liable to produce the identity of the personnel to be engaged during excavation work or period of farming in the campus to the Office of the Officer-In-Charge, Regional Research Station (Old Alluvial Zone), *Uttar Banga Krishi Viswavidyalaya*, Majhian, Dakshin Dinajpur, West Bengal, Pin: 733133. No personnel shall be allowed to enter the campus without prior permission of the Officer-In-Charge concerned.
12. The successful bidder shall bound to do the full works up to satisfactory level in all respect within the stipulated times, otherwise the security money will be forfeited.
13. A Work Completion certificate after five years shall have to be obtained from the Office of the In-Charge, Regional Research Station (Old Alluvial Zone), *Uttar Banga Krishi Viswavidyalaya*, Majhian, Dakshin Dinajpur, West Bengal, Pin: 733133.
14. Earnest money deposit will be released to the successful bidder in due course on receipt of application from the successful bidder to the Registrar, *Uttar Banga Krishi Viswavidyalaya* only after termination of the project and after getting works Completion Certificate. Otherwise, the same may be retained as Earnest money deposit for future actions to be held subsequently. Under no circumstances the Earnest money will be adjusted towards any revenue of any purchased items.
15. If the documents furnished along with the tender paper are proved to be materially false, the bidder shall liable to be black listed apart from the forfeiture of security deposit/Earnest money deposited and cancellation of the work order without prejudice to any other action deemed necessary against him under the rules and orders.
16. The terms and conditions of the use of the land area and execution of work inside the campus shall be deemed to be a part of an Agreement itself which shall have to be executed by the successful bidder before issuance of the work order and shall be binding on the parties.
17. In case of any breaching from the terms and conditions in the Agreement as well as non-acceptance of work order by the successful bidder, the security deposit/ Earnest money deposited shall be forfeited.
