- **Students who obtain their Bachelor Degree from any Private College/University* where the particular Faculty/College/Programme is not accredited by ICAR are not eligible for admission to Master Degree Programme. Students need to upload a certificate in prescribed format (see annexure)/ related format of the respective University issued by the Registrar of the University stating that particular degree programme of the concerned college is accredited by ICAR.**
- **02 Seats shall be reserved for Kashmiri migrants over and above the normal student intake.**
- **SC/ST/OBC candidates of outside the state of West Bengal shall be treated as General category candidates.**
- **Foreign students will be admitted following University Guideline only.**

*Candidates who have passed from private University/College as 1st batch after establishment are exempted from the requirement of accreditation. Those candidates need to submit a declaration from VC/Registrar as per given Annexure - II. However, all the matters related to accreditation of institute shall be decided following latest ICAR guideline regarding this.

No application form without payment of fee will be considered.

Only PWD candidates whose disability percentage are 40% or above, are exempted from application fees. However, there is no PWD seat separately in any department and will be treated as per their respective caste category.

PREPARATION OF MERIT LIST:

The final admission will be conducted strictly on the basis of merit and according to the position in the merit list.

DOCUMENTS REQUIRED DURING APPLICATION PROCESS:

Scanned copy of the following documents/images, as applicable, must be uploaded on online admission portal while applying-

- (a) Passport size photograph of the candidates (Format: jpg, Size 20 kb -100 kb)
- (b) Signature of the candidates (Format: jpg, Size 20 kb -50 kb)

(c) Students need to upload a certificate in prescribed format issued by the registrar of the University stating that particular degree programme is accredited by ICAR.

(d) Self-attested copy of proof of date of birth i.e., either Birth certificate from competent authority or admit card of Madhyamik / equivalent (10th) examination (Format: jpg/pdf, Size 200 kb -300 kb)

(e) Self-attested copies of both sides of the mark sheet of Madhyamik / equivalent (10th) examination (Format: jpg/pdf, Size 200 kb -300 kb)

(f) Self-attested copies of both sides of the mark sheet of Higher Secondary / equivalent (10+2) examination (Format: jpg/pdf, Size 200 kb -300 kb)

(g) Self-attested copies of both sides of the mark sheets of all eight semesters of Bachelors' Degree examination (Format: jpg/pdf, Size 200 kb -300 kb)

(h) Self-attested copy of caste/category certificate (Format: jpg/pdf, Size 200 kb -300 kb)

(i) Self-attested copy of domicile certificate as per the format available in the admission portal or website of the University (Format: jpg/pdf, Size 200 kb -300 kb)

On the day of counseling/ document verification, the following documents need to be produced

(a) Six copies of recent signed passport size photograph similar to the one that has been uploaded during online application.

(b) All certificates that has been uploaded during application and the final degree certificate, in ORIGINAL

(c) Character certificate from the Head of the Institute, last attended.

(d) Migration certificate to be submitted within 1st semester.

(e) Anti-ragging declaration in the given format (to be given within 2 weeks of admission).

(f) The downloaded application form and original copies of all above documents have to be submitted at the time of verification, failing which his/her application will be treated as cancelled.

(g) Domicile certificate for candidates of West Bengal as per the University format

(h) Any other document uploaded during application need to be produced in original

ELIGIBILITY CRITERIA:

(a) Students passed with three years Bachelors' degree course are **NOT ELIGIBLE**.

(b) The minimum age limit for admission to M.Sc. courses is **21 years as on 31.12.2022.**

(c) Candidates must have passed their Bachelors' degree in Agriculture/Horticulture or Forestry or have appeared in final examination in the relevant subject under four year Agriculture/Horticulture/Forestry undergraduate programme from any recognized Indian/Foreign University.

(d) Candidates must have obtained at least 60% marks or its equivalent OGPA (6.00 out of 10.00 or 3.40 out of 5.00 or 2.70 out of 4.00 or 2.00 out of 3.00) in Bachelors' degree for Unreserved and OBC category and 55% marks or its equivalent OGPA (5.50 out of 10.00 or 3.20 out of 5.00 or 2.50 out of 4.00 or 1.80 out of 3.00) in Bachelors' degree for SC/ST candidates.

(e) Candidates of Unreserved and OBC categories must have passed their Higher Secondary (10+2) or equivalent examination with at least 60% marks in aggregate of 5 (five) best subjects including English as compulsory and for SC/ST category candidates the same shall be 50% marks in aggregate of 5 (five) best subjects including English as compulsory.

[Admission of PWD candidates will be subjected to the fitness certificate issued by the medical officer of the University]

#Hostel accommodation will be provided as per availability of room(s) in the hostel. University is not liable to provide hostel to all the admitted students from very beginning of the study programme.

- 4. Questions pattern: MCQ type Questions with four alternatives, each of 1 marks (60x1=60).**
- 5. Qualifying marks of the Entrance Test - 35 % for General, OBC-A & OBC-B categories and 30% for SC, ST categories of the Test.**
- 6. There will be negative marks for MCQ is 0.25 for each wrong answer.**
- 7. The final merit list will be prepared based on marks obtained in Higher Secondary (marks of 5 best subjects including English as compulsory), B.Sc. and Entrance test.**
