The **Provisional Merit List** of candidates for admission to 4 Year B.Tech (Agricultural Engineering) course under Faculty of Technology through Decentralized Counseling for the session 2023-24 is hereby notified for information to all concerned. Candidates are requested to report **personally** for counselling and admission, to be held at **Vivekananda Auditorium** of the University at Pundibari, Cooch Behar **on 9th October 2023 (Monday) by 1.30 p.m. strictly and positively**, with original and self attested copies of all the following documents, failing which the candidature of the candidate will be cancelled.

The remaining or resulting vacancies, if arises, will be filled up through Spot Admission (Date will be notified in the University website). The candidates who will report during 1st counseling will only be called for Spot Admission from the wait listed candidates, if required. A candidate who was called in previous counseling but failed to appear in the counseling will not be entitled to appear in successive counseling.

After commencement of classes of 1st Semester within two months if any vacancy arises due to discontinuation of any student, the University can fill up that seat from the existing merit panel of Decentralized Counseling 2023 through spot admission.

Information submitted in the online Application Form will be treated as final and no change will be entertained in future. The candidates having query, if any, regarding merit list published by the authority, may send email to the id admission_btech@ubkv.ac.in within **05.10.2023 (upto 3:00 pm)**. The email id which was registered by the applicant at the time of online submission of admission form will only be considered for any correspondence. The University reserves the right to rectify the Merit Panel up to **06.10.2023** in the event of detection of any inadvertent mistake during the preparation of merit panel.

- V. Original Domicile Certificate, authenticated by the competent authority for reserved category applicants (SC,ST,OBC) as per guideline with prescribed proforma by WBJEEB.
- VI. Copy with original Adhaar Card
- VII. Copy of First page of the Bank Passbook in the name of the Applicant
- VIII. SIX copies of passport size color photographs (without attestation)
- IX. Affidavit to be submitted by the student and guardian separately within seven days from the date of admission as per the prescribed proforma available in the website www.amanmovement.org or www.antiragging.in as per the UGC Regulations on curbing the menace of Ragging at Higher Academic Institutions 2009 (Under Section 26(1)(g) of the University Grant Commission Act, 1956) vide memo No. F.1-16/2007(Cpp-II) Dated. 17-06-2009.
