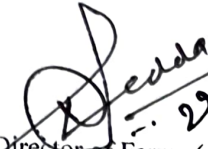
Terms & Conditions

1. The bidders are request to submit the rate in price bid along with self attested photocopy of **Trade License, Pan Card, Aadhar Card or voter identity card** in sealed envelope.
2. Any kind of over writing in price bid, tampering, re-sealing in the sealed envelope submitted by the bidder should be treated as cancelled.
3. The bidders shall have to deposit the Earnest Money Deposit (EMD) an amount **Rs. 10,000.00** (Rupees ten thousand) only by Cash/Demand Draft/Cheque infavor of Uttar Banga Krishi Viswavidyalaya and which is adjustable in case of highest bidders and in case of unsuccessful bidder, the same will be refunded after complete execution of the tender process.
4. The tender value will compare on the basis of prevailing market price provided by the Agricultural Marketing, Govt. of West Bengal. The rate quoted by the bidder was found below than the minimum rate provided by the Agricultural Marketing, Govt. of West Bengal should be treated as cancelled.
5. If it is found that more than one or two bidders quoted same highest rates in comparison to Agricultural Marketing rate, in that case the Director of Farms will negotiate the rate with individual bidder and highest negotiable rate will be considered as a highest bidder.
