Terms & Conditions for disposal of paddy (non-seed)

1. The bidders are requested to submit the rate in quintal along with self attested photocopy of Trade License, PAN card, Voter Card & Aadhaar card, GST Registration, along with the tender, without which the tender will not be accepted.
2. Each bid must be accompanied with a demand draft of an amount of **Rs. 5,000.00 (Rupees five thousand)** as Earnest Money (EMD). The demand draft shall be made in favour of **Uttar Banga Krishi Viswavidyalaya**.
3. The earnest money will be returned to the unsuccessful bidder in due course. For successful bidder, the EMD shall subsequently be treated as security deposit and that shall not carry any interest.
