1. General Instructions:

In the event of e-tendering, intending bidder may download the tender documents from the website: <http://wbtenders.gov.in> directly with the help of Digital Signature Certificate (DSC) or from the UBKV's website www.ubkv.ac.in.

2. Submission of bids:

Both Technical bid and Financial Bid are to be submitted concurrently duly digitally signed by the Authorized Company personnel who is in the pay roll of the Company in the website <http://wbtenders.gov.in>. All papers must be submitted in English language.

3. Eligibility for Quoting:

- Original Equipment Manufacturers (OEM) or Dealers / Distributors / authorized by the manufacturers who are able to supply the assured quantities as per requirement & have requisite qualification for meeting the requirements as per this tender are only eligible for quoting.

- Further, vendors who were declared black listed and/or insolvent by any Govt. Concern/any Institutions in the Country for particular item or items are not eligible to participate in the current tender for that item or items.

4. **Annual Turnover Requirements:**

Vender having average annual Turn Over up to Rs. 30 Lakh or above for the last three financial years 2022-23, 2023-24 & 2024-25 are eligible to participate in the Tender.

5. **Submission of Tenders**

5.1 General process of submission

All the documents including addendum/ Corrigendum related to the tender uploaded by the Tender Inviting Authority form an integral part of the contract. Tenders to be submitted in two envelopes at a time, one is Technical Bid and the other is Financial Bid. The bidders shall go through the tender documents carefully and prepare the required bids.

5.2 Technical details: (Bidders must submit Technical specification along with Catalogue of the item quoted in “Technical Details “Envelope.

5.3 Audited Annual Accounts for last three years 2022-23, 2023-24 & 2024-25 or during the period since formation of the Firm, if it was set up in less than such 3- year period. Bidders whose accounts are not audited must submit 26AS/AIS for the above years as available in the official website of the Income Tax Department, Government of India with other documents stated below:

5.4 Financial Bid

Financial Bid should contain the rate of discount along with printed price list of items for delivery on FOR destination and CIF including applicable taxes. Rate of applicable GST also to be quoted.

6 TERMS & CONDITIONS:

6.1 Bid Information:

- a) The rate of discount quoted by the bidders shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- b) Partial Tender/Incomplete tenders both for Technical and Commercial aspects may subject to cancellation of tender. However, University authority will define the Partial Tender/Incomplete Tender based on the tender evaluation status.

6.2 Evaluation of Tender: Firstly, Technical Bid will be evaluated and thereafter Price Bids of technically qualified bidders will be evaluated for selection of vendor based on the highest discount (H_1) from the current price list of the items.

6.3 Award of Contract: The purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive both technically and commercially.

6.4 Selected Bidders will have to sign an agreement on Non-Judicial stamp with the competent authority of the University

6.5 The vendor should quote and be capable to supply all the necessary items as per Tender. However, the University has the right to procure a part or a whole of the tendered items.

6.6 University enjoys the discretion to select vendor either in full or in part (item wise) for the betterment for pursuing of tender objectives.

6.7 Bidder must submit the tender specific authorisation certificate of the manufacturer of the quoted product.

6.8 Credentials: Documents of supplying similar items in last two previous years in an Institute of Higher Education must be submitted along with the tender.

6.9 Statutory deduction for GST and other Government taxes in the hand of the payee will be made as per the law in force.

6.10 Time Schedule: The supply work must be completed within 30-45 days from the date of receipt of the supply order.

6.11 Place of Supply: UBKV, Pundibari, Cooch Behar-736165; College of Agriculture, Majhian, Dakshin Dinajpur and RRS, Hill Zone, Kalimpong, W.B. and other units under UBKV as & when required.

6.12 Validity of offer: A bidder should spell out in the tender that it shall remain valid for the period of one year with effect from 01/08/2025.

6.13 University reserves the discretion to issue work/ supply order either in full or phase wise depending upon the requirement and selected vendor will not charge any extra amount for such supply and delivery.

6.14 Payment Schedule: 100% Payment will be made after delivery and satisfaction of the item.

6.16 University may forfeit the Security Money (EMD) in the event of the following circumstances:

- i. If selected bidder withdraws the bid before expiry of its validity and after receipt of the Purchase Order.
- ii. If selected bidder does not accept the order after issuing the same or fails to enter into a contract within period mentioned in the order.
- iii. If selected bidder fails to supply the items within the scheduled time as specified in the Purchase Order.

- iv. If before expiry of the warranty period, the supplied items break down or do not function satisfactorily due to the cause related with the item itself or for its installation and not for any reason caused by the University Authority and the supplier denies to take the responsibility to make the supplied items in order.
- v. In case of any false submission /statement by the bidder
- vi. In case of any refusal to abide by terms and conditions or refusal to enter into a written agreement as per prefixed terms and conditions.

6.17 Disposal of Disputes: In case of any dispute, the University's decision will be treated as the final and conclusive. All legal actions are subject to Cooch Behar jurisdiction only.

6.18 Conditional bid may be liable for rejection.

6.19 Liquidated Damages: If the supplier fails to deliver Chemicals Product / Glass Ware and Plastic Ware Product / Consumable items within the time frame(s) incorporated in the work order, the purchaser / consignee shall, without prejudice to other rights and remedies available to the purchaser / consignee under the work order, deduct from the order price, as liquidated damages, a sum equivalent to 2% per month (part of a month to be taken as one month) of delay or part thereof on delayed supply of equipment until actual delivery or performance subject to a maximum of 10% of the order value. Once the maximum is reached purchaser/ consignee may consider termination of the order perform herein. During the above-mentioned period of supply and / or performance, the conditions incorporated herein shall also apply.

7. Discretion of the University:

- i) University may take decision about non-purchase of the said item even after selection of vendor due to its fund constraints.
 - ii) University reserves the right to relax any clause as stated hereinabove for selection of responsive vendor.
 - iii) The University reserves the right not to accept the rate even from the lowest bidder/supplier.
 - iv) The University reserves the right to accept or reject any or all tenders without giving any reason whatsoever.
 - v) The Tender Selection Committee reserves the right to cancel the N.I.T. due to any unavoidable Circumstances and no claim in this respect will be entertained.
- 8. Arbitration:** In the event of any dispute or difference whatsoever arising under the contract or in connection therewith including any question relating to existence, meaning and interpretation of the contract or any alleged breach thereof, the same shall be referred to the sole Arbitration of the Chairman of the Uttar Banga Krishi Viswavidyalaya or to a person appointed by him for that purpose. The arbitration shall be conducted in accordance with the provisions of Arbitration and Conciliation Law 1996.
- 9. Jurisdiction:** All matters of dispute arising out of the order shall be referred to the District Court, Cooch Behar only.
