No. 59-L.— 21st January, 2021.—The Governor having been pleased to order, under rule 66 of the Rules

of Procedure and Conduct of Business in the West Bengal Legislative Assembly, the publication of the following Bill, together with the Statement of Objects and Reasons which accompanies it, in the *Kolkata Gazette*, the Bill and the Statement of Objects and Reasons are accordingly hereby published for general information:—

#### Bill No. 2 of 2021

THE WEST BENGAL KRISHI VISWAVIDYALAYA LAWS (AMENDMENT) BILL, 2021.

### A BILL

to amend the Bidhan Chandra Krishi Viswavidyalaya Act, 1974 and the Uttar Banga Krishi Viswavidyalaya Act, 2000.

Whereas it is expedient to amend the Bidhan Chandra Krishi Viswavidyalaya Act, 1974, and the Uttar Banga Krishi Viswavidyalaya Act, 2000, for the purpose and in the manner hereinafter appearing;

West Ben. Act XLIX of 1974. West Ben. Act XX of 2000.

It is hereby enacted in the Seventy-first Year of the Republic of India, by the Legislature of West Bengal, as follows:—

### The West Bengal Krishi Viswavidyalaya Laws (Amendment) Bill, 2021.

(Clauses 1-3.)

Short title and commencement.

- 1. (1) This Act may be called the West Bengal Krishi Viswavidyalaya Laws (Amendment) Act, 2021.
- (2) It shall come into force on such date as the State Government may, by notification in the Official Gazette, appoint.

Substitution of new section for section 33B of West Ben. Act XLIX of 1974. 2. In the Bidhan Chandra Krishi Viswavidyalaya Act, 1974, for section 33B, the following section shall be substituted:—

"Retirement of Teachers.

33B. Every full-time regular teacher and such other regular employees, who are in receipt of the State Government's notified scale of pay and holding a substantive post in the Bidhan Chandra Krishi Viswavidyalaya, a State-aided University or in any Government-aided college under the said University, shall retire from service on attaining such age as may be determined and notified in the Official Gazette by the State Government, from time to time."

Substitution of new section for section 43 of West Ben. Act XX of 2000. 3. In the Uttar Banga Krishi Viswavidyalaya Act, 2000, for section 43, the following section shall be substituted:—

"Retirement of Teachers.

43. Every full-time regular teacher and such other regular employees, who are in receipt of the State Government's notified scale of pay and holding a substantive post in the Uttar Banga Krishi Viswavidyalaya, a State-aided University or in any Government-aided college under the said University, shall retire from service on attaining such age as may be determined and notified in the Official Gazette by the State Government, from time to time."

#### STATEMENT OF OBJECTS AND REASONS.

The Bill, namely the West Bengal Krishi Viswavidyalaya Laws (Amendment) Bill, 2021, seeks to amend the Bidhan Chandra Krishi Viswavidyalaya Act, 1974 (West Ben. Act XLIX of 1974) and the Uttar Banga Krishi Viswavidyalaya Act, 2000 (West Ben. Act XX of 2000), for the purpose of determining and notifying in the Official Gazette, by the State Government, the retirement age of full-time regular teacher and such other regular employees, who are in receipt of the State Government's notified scale of pay and holding a substantive post in the Bidhan Chandra Krishi Viswavidyalaya or in the Uttar Banga Krishi Viswavidyalaya, State-aided Universities, as the case may be, or in any Government-aided college under the said Universities.

- 2. The Bill has been framed with the above objects in view.
- 3. There is no additional financial implication involved in the Bill.
